**RELEASE AND WAIVER OF LIABILITY FOR ALL VOLUNTEERS - Please Read Carefully!**  
**This Is A Legal Document That Affects Your Legal Rights!**

The Volunteer and Guardian desire that the Volunteer work as a volunteer for the Whitin Community Center and engage in the activities related to being a volunteer (the "Activities"). The Volunteer or Parent/ Guardian of Minor Child Volunteer do hereby freely, voluntarily, and without duress execute this Release under the following terms:

**Release and Waiver.** Volunteer or Parent/ Guardian of Minor Child Volunteer do hereby release and forever discharge and hold harmless Whitin Community Center and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Whitin Community Center. Volunteer or Parent/ Guardian of Minor Child Volunteer understand that this Release discharges Whitin Community Center from any liability or claim that the Volunteer or Parent/ Guardian of Minor Child Volunteer may have against Whitin Community Center with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's Activities with Whitin Community Center, whether caused by the negligence of Whitin Community Center or its officers, directors, employees, or agents or otherwise. Volunteer and/or Parent/ Guardian of Minor Child Volunteer also understand that Whitin Community Center does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness Medical Treatment. Volunteer or Parent/ Guardian of Minor Child Volunteer do hereby release and forever discharge Whitin Community Center from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Whitin Community Center or with the decision by any representative or agent of Whitin Community Center to exercise the power to consent to medical or dental treatment as such power may be granted and authorized in the Parental Authorization for Treatment of a Minor Child.

**Photographic Release.** Volunteer or Parent/ Guardian of Minor Child Volunteer do hereby grant and convey unto the Whitin Community Center all right, title, and interest in any and all photographic images and video or audio recordings made by Whitin Community Center during the Volunteer's Activities with Whitin Community Center, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

**Parental Authorization for Treatment of a Minor Child. AUTHORIZATION AND CONSENT OF PARENT(S) OR LEGAL GUARDIAN(S)**

I grant my authorization and consent for Agents of the Whitin Community Center (hereafter "Supervising Adult") to administer general first aid treatment for any minor injuries or illnesses experienced by the minor. If the injury or illness is life threatening or in need of emergency treatment, I authorize the Supervising Adult to summon any and all professional emergency personnel to attend, transport, and treat the participant and to issue consent for any X-ray, anesthetic, blood transfusion, medication, or other medical diagnosis, treatment, or hospital care deemed advisable by, and to be rendered under the general supervision of, any licensed physician, surgeon, dentist, hospital, or other medical professional or institution duly licensed to practice in the state in which such treatment is to occur.

It is understood that this authorization is given in advance of any such medical treatment, but is given to provide authority and power on the part of the Supervising Adult in the exercise of his or her best judgment upon the advice of any such medical or emergency personnel.

I affirm that I am the parent/guardian of the above named volunteer. I understand that the agency volunteer program does not provide compensation and that the service will not confer on the volunteer the status of a Whitin Community Center employee.
